

Limited Warranty

General

This Limited Warranty applies to the systems and equipment that are sold by or leased from Knight Security Systems, LLC its subsidiaries, affiliates, authorized resellers, or agents (collectively referred to in this Limited Warranty as "Knight Security Systems") with this Limited Warranty ("Knight Security Product").

These terms and conditions constitute the complete and exclusive warranty agreement between you and Knight Security Systems regarding the Knight Security Product you have purchased or leased. These terms and conditions supersede any prior agreements or representations, including representations made in Knight Security sales literature and advice given to you by Knight Security or an agent or employee of Knight Security that may have been made in connection with your purchase or lease of the Knight Security Product. No change to the conditions of this Limited Warranty is valid unless it is made in writing and signed by an authorized representative of Knight.

Warranty Disclaimer

The Limited Warranty Period for all Knight Security provided systems is one (1) year from the date of delivery or, for installed systems, the first day of your beneficial use of the products or systems provided unless otherwise stated in writing. Manufacturer warranties on equipment provided by Knight Security begin on the date of device installation, regardless of beneficial use, and the manufacturer warranty period may vary. The Knight Security Limited Warranty Period shall not exceed nor extend beyond the manufacturer warranty provided on any device.

Warranty Coverage

Knight Security warrants that the Knight Security Product and that you have purchased or leased from Knight Security are free from defects in materials or workmanship under normal use during the Limited Warranty Period. You are entitled to warranty service according to the terms and conditions of this document if a repair to your Knight Security Product is required and requested within the Limited Warranty Period. This Limited Warranty extends only to the original purchaser or lessee of this Knight Security Product and is not transferable to anyone who obtains ownership or use of the Knight Security Product, directly or indirectly, from the original purchaser or lessee.

Repair or Replacement

During the Limited Warranty Period, Knight Security will repair or replace the defective Knight Security Product upon request by you. All component parts or hardware products removed under this Limited Warranty become the property of Knight Security. In the unlikely event that your Knight Security Product has a recurring failure, Knight Security, at its discretion, may elect to provide you with a replacement unit of Knight Security's choosing that is at least equivalent to your Knight Security Product in hardware performance. Knight Security reserves the right to elect, at its sole discretion, to give you a refund of your purchase price or lease payments (less interest) instead of a replacement. THIS IS YOUR EXCLUSIVE REMEDLY FOR DEFECTIVE KNIGHT SECURITY PRODUCTS.

Software and Data
